The undersigned incorporator to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

#### ARTICLE I. . ....

#### NAME

The name of the Corporation shall be: PRODICOL USA CORP.

#### ARTICLE II.

#### PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be: 6201 S.W. 107th Avenue, Miami, Fl 33173

#### ARTICLE III.

#### **PURPOSES**

The purpose for which the corporation is formed and the business and objects to be carried on and promoted by it are as follows:

#### ARTICLE VI.

#### REGISTERED AGENT AND REGISTERED OFFICE

The Registered Agent for this corporation shall be: Maria G. Fernandez, 6201 S.W. 107th Avenue, Miami, Florida 33173., or at such other place as the Board of Directors shall from time to time direct, with appropriate notice being given to the Secretary of State in accordance with the law.

The aforementioned location does not constitute the principal office.

#### ARTICLE VII.

#### DIRECTORS

This corporation shall have not less than one nor more than three directors, as set forth in the By-Laws. The names and street addresses of the first board of directors of this corporation which, subject to these Articles of Incorporation, By-Laws of this corporation, and the Laws of the State of Florida, shall hold office until its successors have been elected and qualified, are:

The foregoing rights of indemnification shall be in addition to and not exclusive of all other rights to which such officer or director may be entitled.
