

ARTICLES OF INCORPORATION

The undersigned incorporator(s), being an individual duly licensed to render consulting sales and service, hereby form a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I. CORPORATE NAME.
