**ARTICLES OF INCORPORATION  
OF  
ARCADIA LIVESTOCK MARKET, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") is ARCADIA LIVESTOCK MARKET, INC.

**ARTICLE II**

The existence of the Corporation shall begin on the date these articles of incorporation are filed with the Florida Department of State.

**ARTICLE III**

The street address of the principal office of the Corporation is 1500 North Brevard, Arcadia, Florida 34266 and whose post office address is Post Office Drawer 511447, Punta Gorda, Florida 33951-1447.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 1,000, par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

**ARTICLE V**

The initial street address of the Corporation's registered office is 115 W. Olympia Avenue, Punta Gorda, Florida 33950. The initial registered agent for the Corporation at that address is Jack O. Hackett II.
