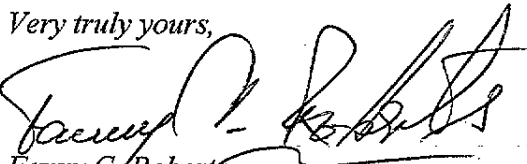

ARTICLE I- NAME

Gold
The name of this Corporation is F.C.R. ~~S~~ INVESTMENTS, INC.

ARTICLE II- DURATION

This Corporation shall have a perpetual existence commencing on September 4th/2000.

ARTICLE III- PURPOSE

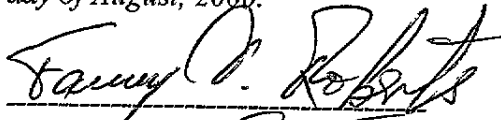
ARTICLE X- INCORPORATION

This Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, in accordance with the provisions of the State of Florida General Corporation Act.

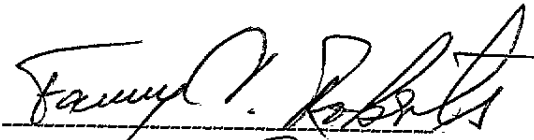

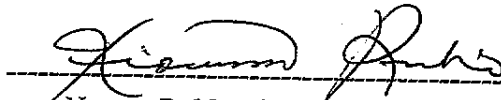

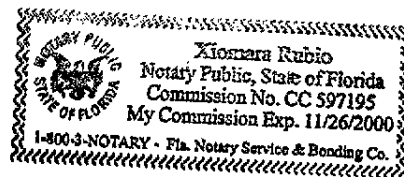
