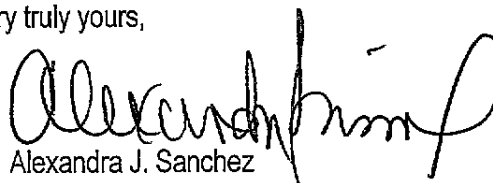

CORPORATE NAME
