**ARTICLE I  
NAME**

The name of this Corporation is **C & E CONSTRUCTION & CONCRETE OF CITRUS COUNTY, INC.**

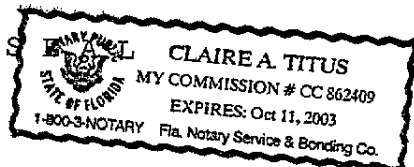
