
ARTICLE IX



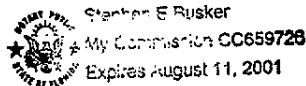


