Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to the Articles of Incorporation of Jett Enterprises Cleaning Division, Inc., which were filed on October 3, 2000 and assigned document number P00000093421.

FIRST: The name of the corporation, prior to the effective date of this amendment, is Jett Enterprises Cleaning Division, Inc.

SECOND: The following amendment to the Articles of Incorporation was properly adopted pursuant to Florida Statutes, Section 607.1006 by the directors and stockholders of the corporation eligible to vote on May 1, 2001, in the manner prescribed in the Florida Statutes:

Article I of the Articles of Incorporation providing for the name of the corporation is hereby amended to read as follows:

ARTICLE I - NAME

The name of this corporation is Jett Cleaning, Inc.

THIRD: The date of the amendment's adoption: May 1, 2001.

The amendment does not affect the amount of stated capital as the amendment merely changes the name of the corporation from Jett Enterprises Cleaning Division, Inc. to Jett Cleaning, Inc.

FOURTH: Adoption of Amendment.

The amendment was approved by 100% of the shareholders. The number of votes cast for the amendment was sufficient for approval.
