ARTICLES OF INCORPORATION

We, the undersigned, being natural persons of legal age, do ORID hereby desire to form a corporation under the laws of the State of Florida and do hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:
