The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I – NAME

The name of this corporation shall be HUDSON-MOREDOCK APPRAISALS, INC.

ARTICLE II – PURPOSE

This corporation is organized for the purpose of conducting real estate appraisals and all lawful business for which corporations may be incorporated pursuant to the General Corporation Act of the State of Florida.

ARTICLE III – CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000 shares of common stock, each having the par value of \$1.00.

ARTICLE IV – INITIAL CAPITAL

The amount of capital with which this corporation will begin business is \$500.00

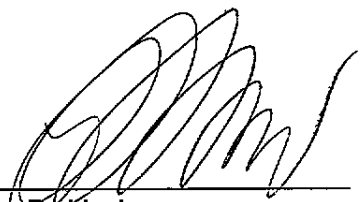

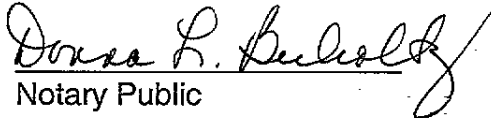

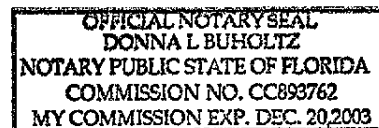
