ARTICLES OF INCORPORATION

OF

Quik, Inc

The undersigned for the purpose of forming a corporation for profit under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be: Quik, Inc

ARTICLE II. DURATION

The term of existence of the corporation is perpetual.

ARTICLE III. PURPOSE

The purpose for which the corporation is being formed is to engage in any business permitted under the laws of the United States and the State of Florida.

ARTICLE IV. CAPITAL STOCK

The aggregate amount of total authorized capital stock of this corporation is One Thousand (1,000) shares of common stock with a par value of \$0.01 each and be all of the same class. No distinction shall exist between the shares of the corporation or between the holders of such shares. Such stock may be issued from time to time without action taken by shareholders, for such consideration as may be fixed from time to time by the board of directors, and shares so issued, the full consideration for which has been paid or delivered, shall be deemed full paid stock and the holder of such shares shall not be liable for any further payment thereon.

ARTICLE V. PREEMPTIVE RIGHTS GRANTED.

Each holder of any class of stock of the corporation shall be entitled to full preemptive rights to purchase any unissued or treasury shares of the corporation and any securities of the corporation convertible into or carrying a right to subscribe to or acquire shares of any such unissued or treasury shares.


