NAME

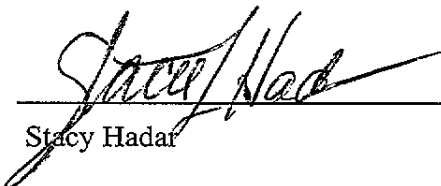
ARTICLE XII
