ARTICLES OF INCORPORATION
OF

The undersigned, acting as Incorporator of a for-profit corporation under the Florida Business Corporations Act, hereby adopts the following Articles of Incorporation:

1. **NAME**

The name of this corporation shall be QYX LYNX, Inc.

2. **INCEPTION OF CORPORATE EXISTENCE**

The corporation shall come into existence on October 1, 2000.

3. **DURATION**

The duration of this corporation shall be perpetual.

4. **PURPOSES**

The purposes of this corporation shall be to design, build, and market information, computer, and communication technologies, data, and systems. The Board of the corporation shall develop and implement programs to further the purposes of QYX LYNX, Inc.

5. **BOARD OF DIRECTORS**

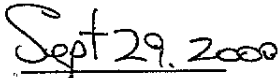

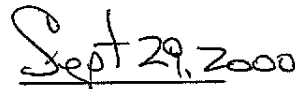
