**ARTICLES OF INCORPORATION OF
CREATIVE LINES BY SANDY CRESS, INC.**

In compliance with the requirements of Florida Statutes § 607, et. seq., the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is CREATIVE LINES BY SANDY CRESS, INC.

ARTICLE II

The existence of the Corporation shall begin on October 1, 2000.

ARTICLE III

The street address of the principal office of the Corporation is Creative Lines By Sandy Cress, Inc., 13911 North Dale Mabry Highway, Suite 5, Tampa, Florida, 33618.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100, par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holder of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

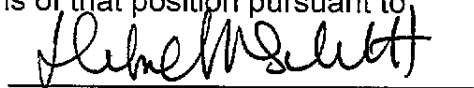
The Corporation shall indemnify its Directors, Officers and Employees and agents to the fullest extent permitted by law.
