# ARTICLES OF INCORPORATION

(in compliance with Chapter 607 and/or Chapter 621, F.S. (Profit))

#### ARTICLE I - Name

The name of this Florida corporation shall be Trinity DataComm, Inc.

### ARTICLE II - Principal Office

# ARTICLE III - Purpose

The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the applicable laws of Florida other than the banking business, the trust company business, or the practice of a state regulated profession.
