ARTICLES OF INCORPORATION

(in compliance with Chapter 607 and/or Chapter 621, F.S. (Profit))

ARTICLE I – Name

The name of this Florida corporation shall be Trinity DataComm, Inc.

ARTICLE II – Principal Office

The principal place of business/mailling address is: 1000 SE 4th Street, Apt. 111, Fort Lauderdale, Florida, 33301.

ARTICLE III – Purpose

The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the applicable laws of Florida other than the banking business, the trust company business, or the practice of a state regulated profession.

ARTICLE IV – Shares

The number of authorized shares of common stock is 1,000 (one thousand) with a \$.001 (one tenth of one cent) par value per share.

The initial ownership of the corporation shall be evidenced by 100 (one hundred) shares issued to each of the following individuals: David Pardue, Scott Gentry, Greg Kirsch. The remaining shares shall be unissued until their disposition is determined by the duly authorized action of the directors.

ARTICLE V – Initial Officers/Directors

indemnifies the officers and directors of the corporation to the fullest extent permissible under Florida law.
