## ARTICLE I. NAME AND ADDRESS

## ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

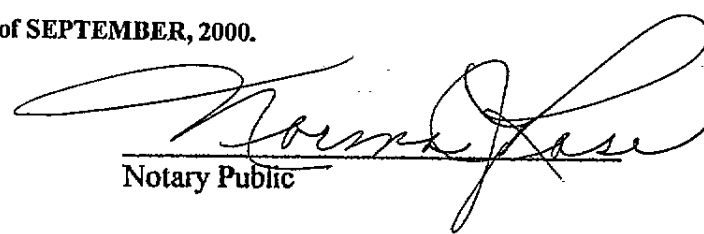

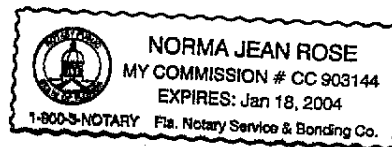
