*The undersigned incorporator(s), hereby make, subscribe, acknowledge and file with the Secretary of the State of Florida, these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.*

**ARTICLE I - CORPORATE NAME**

*The name of this Corporation shall be T & R FIRE HYDRANT SERVICING, INC., 267 2nd Street S. W., Largo, Florida 33770.*

**ARTICLE II - DURATION**

*This corporation shall exist perpetually unless dissolved according to Florida law.*

**ARTICLE III - PURPOSE**

*The corporation is organized for the purpose of engaging in any transaction or business activities, both domestically and abroad, for which corporations are permitted under the laws of the United States and the State of Florida.*

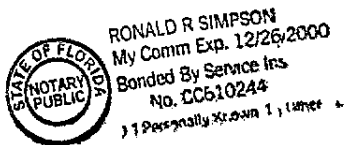
