# ARTICLES OF INCORPORATION

OF

# FIRSTCHOICE DOLLAR PLUS, INC.



The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

#### **ARTICLE ONE**

The name of the corporation is: **FIRSTCHOICE DOLLAR PLUS, INC.**The principle address of the corporation is: VILLAGE SQUARE "EAST", BAY #29, 3411 Woolbright Rd., Boynton Beach, FL 33436.

#### **ARTICLE TWO**

This corporation shall commence its existence upon filing and shall exist perpetually thereafter unless sooner dissolved according to law.

#### **ARTICLE THREE**

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
