ARTICLES OF INCORPORATION OF

CORRECTIONAL CORPORATION OF LATIN AMERICA, INC.

in compliance with Chapter 607, Florida Statutes

ARTICLE I - NAME OF CORPORATION:

The name of the corporation shall be: Correctional Corporation of Latin America, Inc.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS:
