corporation is organized:**

**I.
Name**

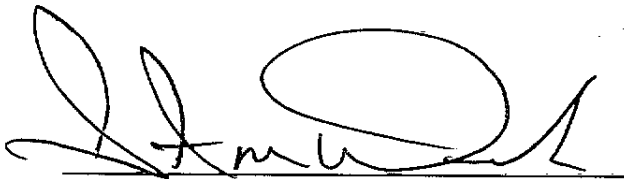

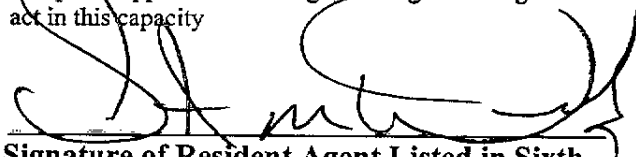
