ARTICLES OF INCORPORATION

OF

PHYLLIS SILVERMAN CONSULTING, INC.

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I - NAME

The name of this Corporation is PHYLLIS SILVERMAN CONSULTING, INC.
