# ARTICLES OF INCORPORATION

OF

# LE'S NAILS, INC.



I, MICHAEL O. ALBERTINE, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

# ARTICLE I

The name of this corporation shall be LE'S NAILS, INC., and the initial address of this corporation shall be 2442 Sheridan Street, Hollywood, Florida 33020.
