The Articles of Incorporation of Systems Prompt, Inc. are as follows:

I.

The name of the corporation is Systems Prompt, Inc. (the "Corporation").

II.

The mailing address of the initial principal office of the Corporation is 2480-4 Briarcliff Road, Suite 359, Atlanta, DeKalb County, Georgia 30329-3034.

III.

The purpose of the Corporation is to engage in any form or type of business for any lawful purpose or purposes not specifically prohibited to corporations for profit under the laws of the State of Florida and to have all the rights, powers, privileges and immunities which are now or hereafter may be allowed to corporations under the laws of the State of Florida.

IV.

The number of shares the Corporation is authorized to issue is 10,000 shares of no par value capital stock, all of which shall be designated "Common Stock". The shares of Common Stock shall have unlimited voting rights and shall be entitled to receive all of the net assets of the Corporation upon liquidation or dissolution.
