

ARTICLES OF INCORPORATION OF SPANISH FLARE, INC.



In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE 1

The name of the corporation ("Corporation") is SPANISH FLARE, INC.

ARTICLE 2

The existence of the corporation shall begin immediately effective upon the acceptance of these Articles of Incorporation by the Florida Secretary of State.

ARTICLE 3

The address of the principal office of the Corporation is 3602 North 53rd Street, Tampa, Florida 33619.

The maximum number of shares this Corporation is authorized to issue is two thousand (2,000), all of which shall be Common Shares with par value of one cent (\$0.01) per share.
