

The undersigned acting as subscriber of a corporation under the Florida Corporation Law adopts the following Articles of Incorporation for the above-titled corporation.

ARTICLE I

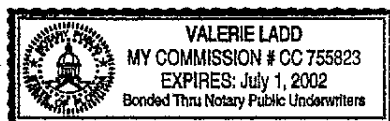


