ARTICLES OF INCORPORATION

OF

CORNERSTONE SERVICES, INC.

TALLAHASSEE FLORIE

The undersigned incorporator makes, subscribes, acknowledges and files with the Department of State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I

NAME and ADDRESS

The name of the corporation is CORNERSTONE SERVICES, INC.. The address of the corporation is 3660 Maguire Boulevard, Orlando, Florida 32803.

ARTICLE II

TERM OF EXISTENCE
