## Articles of Incorporation Of Accelerated Holdings Company

The undersigned for the purpose of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

#### Article I

The name of this corporation is ACCELERATED HOLDINGS COMPANY with its principal office located at 111 Tech Dr. Sanford, FL 32771

#### Article II

This Corporation shall have perpetual existence.

#### Article III

The nature of this business to be transacted by this corporation is as follows:

- 1.) To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.
- 2.) To buy, sell, lease, exchange real estate held by this corporation.
- 3.) To consolidate or merge with any other corporation
- 4.) To have a corporate seal, which can be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any other manner reproduced.
