The undersigned for the purpose of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

Article I

The name of this corporation is ACCELERATED HOLDINGS COMPANY with its principal office located at 111 Tech Dr. Sanford, FL 32771

Article II

This Corporation shall have perpetual existence.

Article III

The nature of this business to be transacted by this corporation is as follows:

- 1.) To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.
- 2.) To buy, sell, lease, exchange real estate held by this corporation.
- 3.) To consolidate or merge with any other corporation
- 4.) To have a corporate seal, which can be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any other manner reproduced.
- 5.) To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use and otherwise deal in and with real or personal property or any interest therein, wherever situated.
- 6.) To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets.
- 7.) To purchase, take, receive, subscribe for, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests

in, or obligations of, other domestic or foreign corporations, associations, partnerships, or individuals, or direct or indirect obligations of the United States or of any other government, state, territory governmental district, or municipality or of any instrumentality thereof.

- 8.) To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income
- 9.) To lend money for corporate purchases, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.
- 10.) To have and exercise all powers necessary or convenient to effect its purpose.
- 11.) To have, exercise and enjoy all of the rights and privileges of corporations for profit as conferred by the laws of the State of Florida, it being expressly provided that the enumeration of the specific powers and purposes shall not be held to limit or restrict in any manner the general powers of the Corporation.

Article IV

This corporation is authorized to issue 1000 shares of common stock, which shall be the aggregate number of shares, which this Corporation has the authority to issue.

Article V

This corporation shall have a two directors. The initially registered office of this Corporation is 111 Tech Dr. Sanford, FL 32771. The numbers of directors may be increased or decreased at any time by the bylaws adopted by the shareholders, but shall never be less than one. Article IX

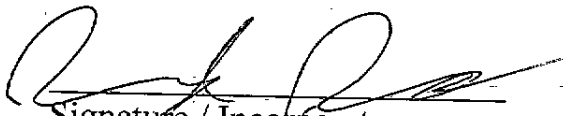

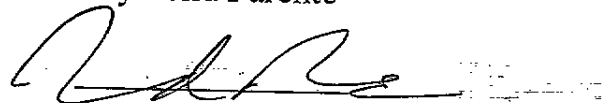

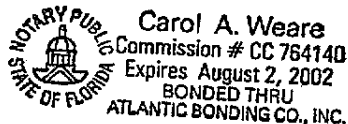
