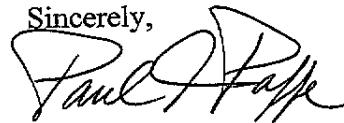

## Articles of Incorporation

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

### Article I

The name of the corporation is:  
**Technology Visions, Inc.**

### Article II

The period of its duration is perpetual

### Article III

The purpose is to engage in any activities or business permitted under the laws of the United States of America and the State of Florida. Primary concentration of business will be the marketing and selling of technology-related products and services to commercial, non-profit, government and educational institutions.

### Article IV

The capital stock of this corporation shall be divided into One Thousand Shares (1,000) with a par value of one dollar (\$1.00) per share, fully paid and non-assessable.

Authorized Shares. One hundred thousand (100,000) shares of common stock at a par value of one dollar (\$1.00) per share shall be authorized.

Initial Issue. One Thousand (1,000) shares of the capital stock of the corporation shall be issued for cash at a par value of one dollar (\$1.00) per share.

Dividends. The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the corporation.
