

ARTICLE I - NAME

The name of the corporation is FIRST FLORIDA TITLE SERVICES, NC. hereinafter called the "Corporation")

ARTICLE II - PURPOSE



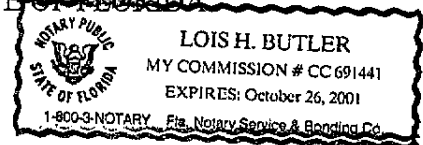
