

BY THESE ARTICLES OF INCORPORATION the incorporators form a corporation for profit under Florida Law.

1. NAME. The name of this corporation is ENTERTAINMENT CONNECTIONS, INC.

7. DIRECTORS. The initial Board of Directors shall have two members whose names and addresses are as follows:



