


- I. The name of the corporation is JAIL HOUSE BLUES BAIL BONDS INCORPORATED.





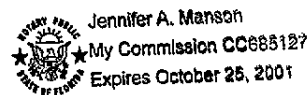
