

# ARTICLES OF INCORPORATION OF



# PREMIUM CAPITAL INC.

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

## ARTICLE 1 - NAME

The name of the Corporation is PREMIUM CAPITAL INC.

## ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall engage in any activity of business permitted under the laws of the United States and of the State of Florida.

#### ARTICLE 3 - PRINCIPAL OFFICE

#### ARTICLE 4 - INCORPORATORS

#### **ARTICLE 5 - PRESIDENT**

The initial President of the corporation shall be Sasson Joury. Whose address shall be the same as the principal office of the corporation.

- 6.4 The board of directors of the Corporation may, by articles supplementary, classify or reclassify any unissued stock form time to time by setting of changing the preferences, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualifications, or term or conditions of redemption of the stock.
