ARTICLES OF INCORPORATION

OF

VICTORIA PARK MORTGAGE, INC.

Pursuant to the requirements set forth within Chapter 607 of the Florida Business Corporation Act, the undersigned, being a natural person, does hereby act as the incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation (hereinafter referred to as the "Company") shall be Victoria Park Mortgage, Inc.

ARTICLE II

The existence of the Company shall begin on the date of acknowledgment of these articles of incorporation and shall have perpetual existence.

ARTICLE III

The Company is authorized to issue 10,000 shares, all of which shall be Common Shares having a no par value. 
