

OF

ARTICLE I
NAME

The name of the corporation is: DAN'S STAR, INC., at 3471 N.
Federal Hwy. #601, Ft. Lauderdale, FL 33306.

ARTICLE II
DURATION

This corporation shall have perpetual existence.

ARTICLE III
PURPOSE

The corporate existence will be effective this date October 3, 2000.

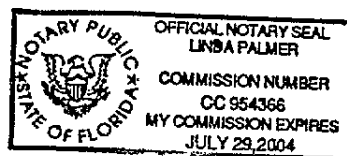
