CERTIFICATE

OF

ARTICLES OF INCORPORATION

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the General Corporation

Law, Chapter 607, Florida Statutes, 1985.

ARTICLE I.

The name of this corporation shall be **ON THE STALL INDOOR ADVERTISING, INC.** and its corporate address shall be; 3915 SE 13th

Street, Ocala, Florida 34471.

ARTICLE II.

General Nature of Business

The general nature of the business to be transacted by the corporation shall be:

- 1. Advertising.
- To buy, lease, hold and sell real estate and personal property.
- 3. To purchase, sell and hold stock in other corporations.
- 4. To erect buildings of any kind, and to hold, lease and sell the same.
- 5. To form co-partnership with other corporations or persons.
- 6. To engage in other lawful business which a corporation

may be permitted to engage in under the laws of the State of Florida; the powers of the corporation not being limited by the general nature of the business to be transacted as herein specified.

7.
