Re: Request for Waiver of 2001 UNIFORM BUSINESS REPORT late filing fee.

Please find the enclosed check in the amount of \$150.00 being **conditionally tendered** as the filing fee with the attached 2001 UNIFORM BUSINESS REPORT for SAVE Incorporated. **Please read this letter and make a determination on the Request for Wavier of late filing fee before this check is deposited and negotiated.**

Save Incorporated was formed and incorporated in the State of Florida as of October 3, 2000. As of the writing of this letter the corporation is still **inactive**. No Corporate business has been transacted up to this point and will not be until a contract for our services can be obtained with the U.S. Department of Defense or some other Federal Government Agency.

SAVE Incorporated was not aware of the requirement for filing the 2001 UNIFORM BUSINESS REPORT until sometime in late April 2001. It was believed that the Report was due by May 15, 2001. On May 12, 2001 we became aware that the deadline was actually May 1, 2001.

We are requesting a one-time waiver of the \$400 late filing fee. It is our understanding that there have been a considerable number of 2001 UNIFORM BUSINESS REPORTS filed after the May 1st due date, and that other waivers have been granted.

As stated above, we are requesting this waiver and conditionally tendering the normal \$150.00 filing fee. **If the waiver is not granted, then we request that you return the enclosed check rather than depositing it.** Unfortunately, it would be much cheaper for us to form a new corporation rather than pay the \$150.00 filing fee, plus the \$400 late fee. This in itself does not seem logical or reasonable. Why should the late filing fee be 266.6% times the normal filing fee? That certainly is excessive by any standards and needs to be reviewed in our opinion. We do not want to have to go to the trouble and expense to re-incorporate, but may have to if the waiver is not granted.

We appreciate your prompt attention and response to this matter.
