## ARTICLES OF INCORPORATION

OF

THREE MURPHY, INC.

#### I. NAME

The name of the corporation is THREE MURPHY, INC.

## II. TERM OF EXISTENCE

This corporation shall have perpetual existence.

#### **III. NATURE OF BUSINESS**
