In compliance with the requirements of Chapter 607 of the Florida Statutes, the undersigned, all of whom are residents of Florida and all of whom are of full age, have voluntarily associated themselves together for the purpose of forming a corporation for profit and do hereby certify:

ARTICLE I

The name of the corporation is Reppy Enterprises, Inc. Hereafter called the "Corporation".

ARTICLE II

The principle office of the Corporation is located at 2737 Gables Drive, Eustis, Florida 32726.

ARTICLE III
PURPOSE OF THE CORPORATION

This Corporation contemplates profit to the shareholders thereof through the development or acquisition of businesses. Therefore, the specific purpose for which it is formed is to provide for the management and regulation of affairs of the Corporations business interests.

ARTICLE IV


