WE, the undersigned, do hereby associate ourselves together and subscribe these Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, Chapter 607 and subject to the following provision:

ARTICLE ONE

The name of the corporation shall be: PROTECTIVE INSURANCE AGENCY, INC.

This corporation shall have perpetual existence and may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

The general nature of the business to be transacted by this corporation shall be:

- a) General insurance agency.
- b) To manufacture, purchase or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares,
