This corporation shall begin existence upon the filing of these Articles of Incorporation, and shall exist perpetually.



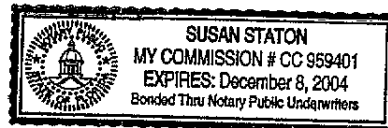


