In compliance with the requirements of F.S. Chapter 607 the undersigned being a natural person hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE 1: The name of this corporation is Superior Building Resource Group, Inc.

ARTICLE 2: The existence of the corporation shall begin on filing of these Articles.

ARTICLE 3: The street address of the principal office of the Corporation is 2502 Carr St., Palatka, FL 32177.

ARTICLE 4: The maximum number of shares authorized for issue is 1,000, par value \$1.00 per share, all of which shall be common shares. 
