ARTICLES OF INCORPORATION

In compliance with Chapter 607 and/ or Chapter 621, F.S. I the undersigned incorporator, hereby make, subscribe, acknowledge and file with the Department of the State of Florida, and adopts the following Articles of Incorporation for such corporation:

Article I -- Name

The name of this corporation shall be **Urbanfolk Dot Com, Inc.**

Article II-- Principal Office

Article III ---Purpose
