**ARTICLES OF INCORPORATION  
OF  
SAFARI AIRLINES, INC.**

The undersigned, acting as the incorporator of SAFARI AIRLINES, INC., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation.

**ARTICLE I - NAME**

The name of this corporation is SAFARI AIRLINES, INC. The mailing address of the Corporation shall be 119 Clipper Lane, Jupiter, Florida 33477.

**ARTICLE II - CORPORATE EXISTENCE**

The Corporation will exist commencing on the date of filing these Articles of Incorporation with the Florida Department of State.

**ARTICLE III - DURATION**

The corporation shall exist perpetually.

**ARTICLE IV - PURPOSE**

This Corporation is organized for the specific purpose of scheduled airlines and, in general, to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

## ARTICLE V - CAPITAL STOCK

The maximum number of shares of capital stock that the Corporation is authorized to issue and have outstanding at any one time is ten thousand (10,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

## ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT
