Ladies and Gentlemen:

Pursuant to your call today, you indicated that you received the copy of the Uniform Business Report for 2002 without the signature for the change in Registered Agent.

As I mentioned in my last letter, we maintain a signed original in our file in order to provide copies in the event of an inquiry.

Apparently, the officer and registered agent did not sign your original when mailed in April 2002.

I am forwarding my file original to you for your records.

You also indicated that corporation should have received a request from your office to add the Registered Agent's signature. The corporate check was accepted and is credited to their account. A review of the matter with Mr. Serrano indicated that he never received a request from your office. There was no lack of diligence on Mr. Serrano's part to comply, but simply was unaware that you had requested additional information. Further, there is no reasonable basis for withholding a signature when he had already signed the bottom. I suspect that Mr. Serrano simply forgot to sign in the additional space.

Accordingly, we respectfully request that you accept the form enclosed to complete the filing of Serrano Enterprise, Inc. as timely filed prior to May 1, 2002.

As you know, penalties were brought forth by statute in order to enforce compliance and to inflict financial penalty upon those who willfully fail to follow the law or show a disregard for the law. I believe that Mr. Serrano intended to follow the law and paid the fee and simply erred in signing the Uniform Business Report in all the right places. The fees charged by our firm to communicate with you and try to resolve this matter are punitive at best.

We ask that you notify the corporation in writing as to the satisfactory close to this matter. However, if you feel you cannot make the changes requested without penalizing them with reinstatement fees, etc., please consider this letter or formal request for an appeals hearing in your Tampa, Florida office.


