

*ARTICLE VIII. AMENDMENT*

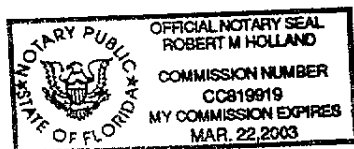
