ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this corporation is MOZART'S CAFÉ & BAKERY CORPORATION.

9 AH IO: 32 SEE, FFORIDA

ARTICLE II - DURATION

The duration of the corporation shall be perpetual and shall commence upon the signing and acknowledging of these Articles.
