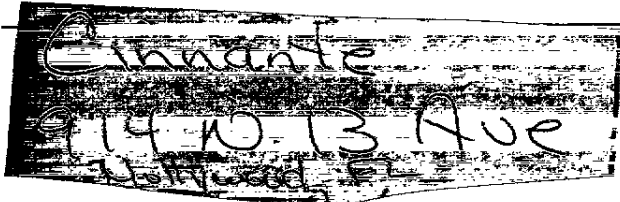

I, the undersigned, a natural person competent to contract, do hereby make
subscribe and file these Articles of Incorporation for the purpose of organizing a
