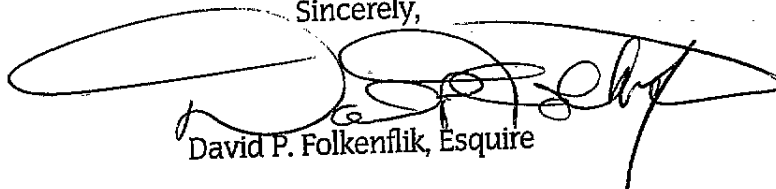

ARTICLES OF INCORPORATION

OF

The undersigned PATRICK LAMB does hereby make, subscribe, acknowledge and files these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I

NAME

ARTICLE VII

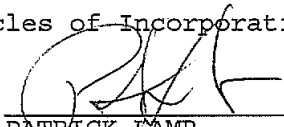

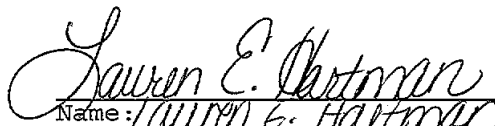
